The account owner and authorized signers jointly and individually agree to indemnify, release, and hold Rize CU harmless from any claims, demands, expenses, losses, or damages – including legal fees – arising from or related to the issuance or use of any card or PIN under this agreement. You acknowledge you will not have the benefit of consumer laws that limit liability for unauthorized use of the card or PIN.
